IF YOU DESIRE TO HAVE A COPY OF YOUR COMPLETED FORM FILED BY THE POLICE DEPARTMENT, BRING OR MAIL THE FORM TO THE DEPARTMENT AT YOUR EARLIEST CONVENIENCE.

IT IS RECOMMENDED THAT BOTH PARTIES COMPLETE THIS FORM, AND THAT A COPY OF EACH BE FILED WITH THE DEPARTMENT IN OFFICIAL RECORDS FOR YOUR VERIFICATION NEEDS AND FOR INSURANCE COMPANY REQUESTS. ALSO, A COPY MAY BE MADE FOR EXCHANGE OF INFORMATION BETWEEN PARTIES INVOLVED, ATTORNEYS AND INSURANCE AGENTS AND/OR ADJUSTERS.

IF YOU HAVE ANY QUESTIONS, WE WILL BE PLEASED TO ANSWER THEM DURING BUSINESS OFFICE HOURS IN THE ADMINISTRATION DIVISION, OR AN ON-DUTY SUPERVISOR MAY ASSIST YOU WITH QUESTIONS YOU MAY HAVE WITH REASONABLE TIME RESPONSE.
